## **LETTER FROM THE PRESIDENT**

To our current & future members

Thank you for your support of the Great Salt Pond and the work of The Committee for the Great Salt Pond. I can report that the pond is healthy, our water quality monitoring program is very active and the CGSP Swim continues to grow as a demonstration of how great the pond truly is. We are also pleased to work with the Double Ender Committee (4th of July parade/celebration) to support an iconic island event among boaters. And we remain vigilant with the Champlin's case to protect the pond.

Our goal is both to support the pond today and to protect its health for tomorrow. We maintain the longest-running water quality database monitoring the pond's health, and we strive to manage the balance among commercial, recreational and environmental activities. We support aquaculture and well understand the reality of appropriate commercial development. The sugar kelp farming pilot project is a perfect example of this as well as our support of the current oyster farms. Given initial water quality findings, we are already digging into the tributary data that may point to some potential issues.

The CGSP is focused on asking tough questions about development around the pond. For example, the CGSP presented concerns to the Town and has currently halted the rebuilding of a road to Bean Point by the US Fish & Wildlife Service. The CGSP also stepped forward to build walkovers over the dunes on Corn Neck Road thereby protecting the Great Salt Pond. And the CGSP is actively involved in the new Harbor Management Plan.

Given a number of potential new activities on the horizon (new commercial development, town facilities, housing, etc), the CGSP is working to ensure the pond remains one of Block Island's prime assets. While improved boater amenities – showers, toilets, etc. – are needed, we will continue to work with the Town of New Shoreham to ensure the pond and island benefit from these facilities as much as the boaters. # Kelp Farming - New To BI and the Great Salt Pond

Now that November is here, Block Island is just weeks away from deploying its first kelp farm. Interest in farming sugar kelp is growing among shellfish farmers and fishers in the Northeast. In recent years, the industry has spread from Maine to as far south as Connecticut, and at least nine Rhode Island aquaculturists have begun growing kelp since 2016. The kelp is "planted" (using seed from native RI kelp beds) in November and harvested before the end of April, giving us the ability to grow a crop in the Great Salt Pond during the absence of competing uses. Besides being a healthy, nutrient-dense and organic food for people, livestock, and pets, kelp also sequesters carbon and nitrogen and reduces ocean acidification, making it very beneficial to the waters in which it grows. # **Great Salt Pond Water Sampling Continues**

Multiple Great Salt Pond sites and its tributaries were sampled since last May. Alternating sites every two weeks, the testing and gathering were consistent, weather permitting.

At this time, full analysis of the season's data is incomplete. There has been a rush of all watershed groups to submit their final information. Elizabeth Herron, The University of Rhode Island, recently compared this year's results to previous years:

The Great Salt Pond continues to be in good health, but several of the streams that feed into it continue to frequently contain high levels of nutrients and bacteria. Those streams tend to be fairly small volume tributaries, so overall loading is not large, making those inputs mostly localized problems. But working to identify, and if possible, limit sources would help the pond be more resilient to other impacts such a climate change and recreational use pressures."

We will resume Great Salt Pond testing in May, 2019.



# **Update on the Champlin's Marina Expansion Case**

The Champlin's Marina application to the CRMC for its marina expansion was finally, after almost 10 years of hearings and appeals, denied by a 10-0 vote of the RI CRMC in 2010. Normally this would mean that the applicant would have to come back to the CRMC with a new application, for a new marina expansion plan, to receive consideration. In 2012 Payne's Dock applied for a much smaller expansion (80' dock length extension and 12 boats vs 240' dock length extension and nearly 100 boats for Champlin's) which was approved by the CRMC in the Fall of that year. Champlin's subsequently filed a suit against the CRMC in RI Superior Court claiming that the approval of the Payne's Dock marina expansion application, and the denial of the Champlin's Marina expansion application, amounted to disparate and discriminatory treatment. The RI Superior Court ordered the CRMC to hold hearings and collect evidence on the above and to determine if in fact, the CRMC had discriminated against Champlin's Marina when they approved the Payne's Dock application. A number of hearings were held, at which the Committee for the Great Salt Pond Board Members Sven Risom and Henry duPont testified on behalf of the Committee: that because of the significantly greater impacts of the proposed Champlin's expansion as compared to the proposed Payne's Dock expansion, the CRMC was justified in denying one and granting the other. In August of 2013 the CRMC finally found, in a 6-2 vote that both applications had been duly considered under the same criteria and no disparate treatment was involved. The case has now been sitting at the Superior Court for final disposition since March of 2014. We expect that the Superior Court's decision, in CRMC's favor, will put the lid on the Champlin's Marina application, but would not be surprised if other marina expansion plans are forthcoming.

The CGSP is proud that our active participation in opposing inappropriate development in and around the Great Salt Pond has significantly helped to preserve and protect one of Block Island's most valuable natural resources.

## **Our New Treasurer**

We would like to welcome our incoming Treasurer, Cindy Pappas, who has graciously accepted the position after our Board of Directors voted unanimously to appoint her. Cindy, who has served as a Board member for the past three years, will be starting January 1, 2019. Our current Treasurer, Dan Barker, will be retiring from his position at St. Ann's-by-the-Sea on December 31, 2018, and moving back to New York.

They include Chair of the Affordable Housing Board for the TNS and serving on the International Student Center Board.
