## A LITTLE ABOUT TNC

Founded in 1951, The Nature Conservancy (TNC) is a global conservation organization dedicated to conserving the lands and waters on which all life depends. TNC has been working on Block Island (BI) since 1972, and officially launched the BI program in

1991 when the organization named the island as one of 12 "Last Great Places" in the western hemisphere. This special designation highlights the island's abundance of rare species and the community's unique support for conservation.



Over the last thirty years, the BI program has expanded into a multi-faceted program of land acquisition and restoration, scientific research, nature education, public outreach, stewardship, and community science. We have seven year-round staff members and each year we welcome seasonal assistants and volunteers to join our team in support of our dynamic program.




This upcoming field season will mark the eighth year of our extensive scientific study of the Great Salt Pond (GSP). The goal of this study is to become more knowledgeable of the pond's ecological functions as a critical nursery habitat and offshore refuge for a wide array of species. To capture what happens in the GSP over time, TNC standardized a suite of monitoring surveys to document biotic and abiotic features such as abundance and diversity of resident and migratory finfish species, water quality parameters, bay scallop populations, and accretion and secretion patterns of salt marsh habitats surrounding the pond. Collectively, this time series study provides usable datasets and accrues valuable information to help inform our work going forward, so that in years to come, TNC can confidently advise and work with our partners and the island community to help keep the GSP a sustainable resource.
